- ξ Members of the team roster must be from the same school district
- ξ Tenths will be covered - must weigh in with singlet on
- ξ There is not a maximum weight for the HWT position
- ξ Each team will wrestle at least two times and no more than three times
- ξ We will allow three coaches per team
- ξ We will have 16 wrestling mat surfaces, ½ of a full size mat per surface
